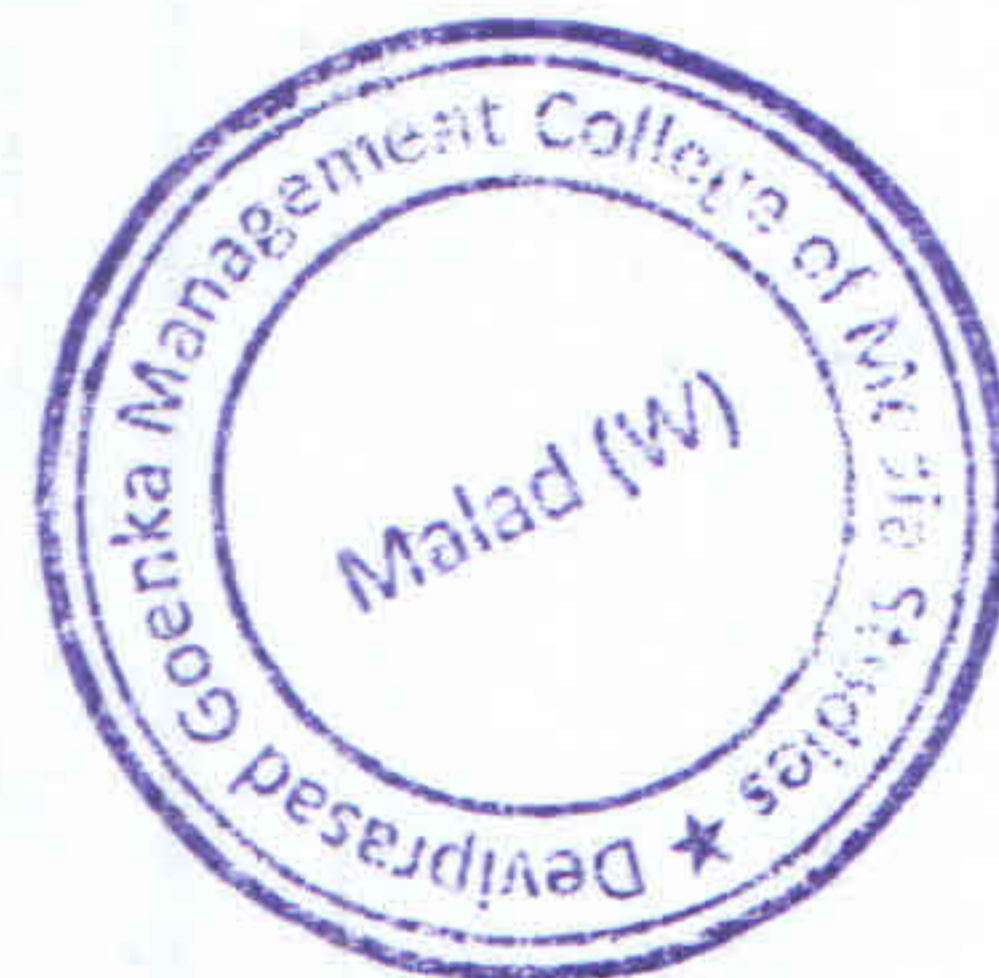
Further, if it is observed that 50% or less students admitted as per sanctioned intake, the action of de affiliation will be initiated against the college.

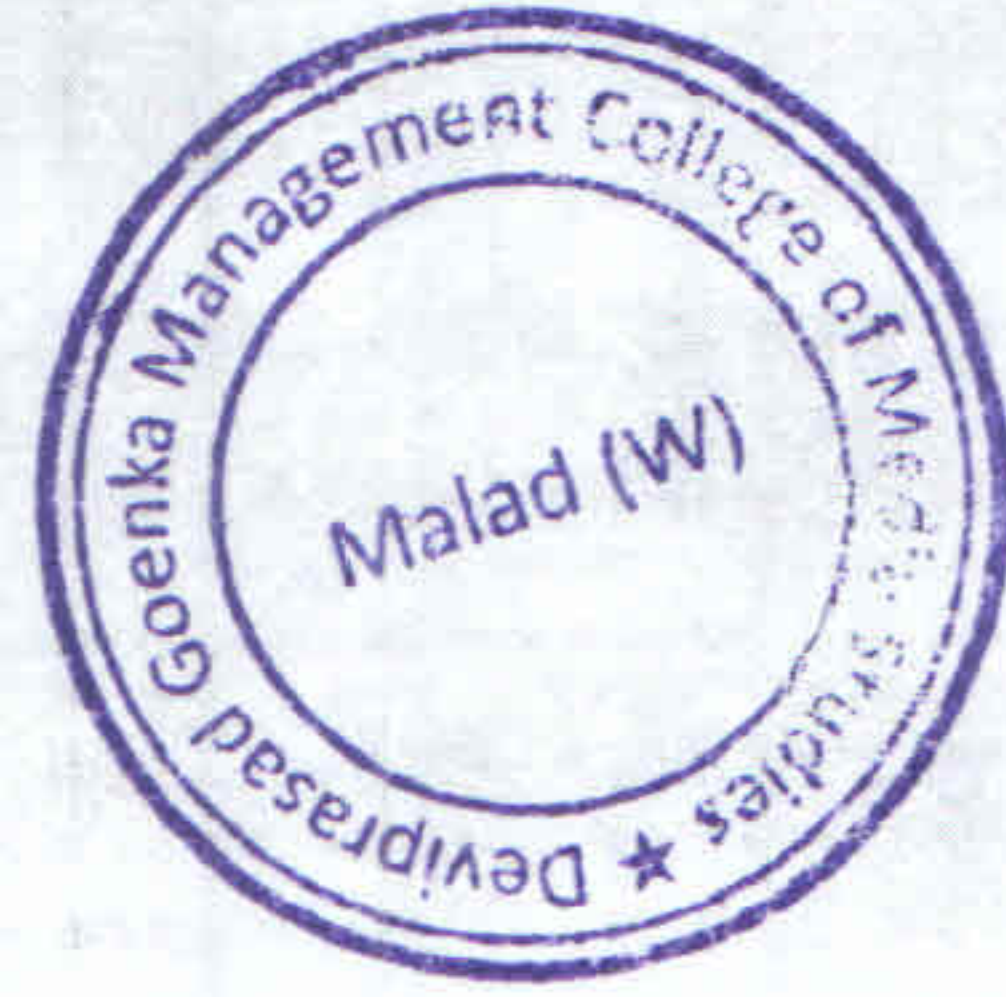

In this connection, I am directed to inform you that your request has been granted and you are permitted to accommodate additional students per division over and above the intake capacity for the following Courses in a division, subject to the following conditions for the academic year 2021-22 only.

Increase in number of students should be granted subject to following conditions:

1. The above additional seat allocation is valid only for the academic year mentioned above.
2. The College will strictly adhere to the State Government reservation policy applicable for admission purpose.
3. Number of additional seats are allotted to the College is as per resolved by the Committee OR on the basis of additional seats requested by the College Whichever is less.
4. Colleges are directed to strictly adhere to the admission schedule notified by the University.
5. Admission to the additional seats permitted should be strictly on the merit basis.
6. There shall be **no management quota** for these additional seats.
7. Colleges cannot claim extra workload for additional allotted seats.
8. The Colleges applying for additional seats are required to have the necessary infrastructure to accommodate these students.
9. In case of autonomous College, the total seats allotted as above are inclusive of the extra seats as per the Circular No.CAD/AFF/ICC/(2021-22)/08/of 2021, dated 4th August, 2021.
